

## **DEMILLE BLUE BLOODS PUPPY SALES CONTRACT**

The Seller, Amileah Crawford, and the Buyer, \_\_\_\_\_,  
hereby agree as follows:

The Seller hereby sells to the Buyer a puppy from DeMille Blue Blood's Great Weimars.

The puppy is being sold for the following price:

**Option A: \$1500.00 USD for a 1<sup>st</sup> or 2<sup>nd</sup> pick from a specific litter** - A non-refundable \$500.00 USD deposit has been paid by Buyer to Seller to confirm that Buyer fully intends to complete the purchase of the puppy, and to hold the Buyer's 1<sup>st</sup> or 2<sup>nd</sup> place in line to choose a pup from a specific litter. The remaining balance of \$1000.00 USD must be paid in full once the buyer has chosen their puppy when their turn comes up, and prior to the puppy leaving the Seller's possession. If buyer fails to choose a puppy when their turns comes up for the litter they chose, then their name is moved to the bottom of the Option B waiting list (buyer forfeits \$200 of their deposit, the remaining \$300 of their deposit is then applied toward the total purchase price of \$1000.00 for a pup that is not a 1<sup>st</sup> or 2<sup>nd</sup> pick). Should no one claim the 1<sup>st</sup> or 2<sup>nd</sup> pick spots for any given litter, then those spots are offered to the waiting list at the usual \$1000.00 price.

**Option B: \$1000.00 USD to join the waiting list for a puppy available in any litter that is not a 1<sup>st</sup> or 2<sup>nd</sup> pick** - A non-refundable \$300.00 USD deposit has been paid by Buyer to Seller to confirm that Buyer fully intends to complete the purchase of the puppy, and to hold Buyer's place in line on our waiting list to choose a puppy. The remaining balance of \$700.00 USD must be paid in full once the buyer has chosen their puppy when Buyer's turn to choose comes up, and prior to the puppy leaving the Seller's possession. If the Buyer does not find a puppy they want in the first litter offered to them, the Buyer may choose to have the Seller save Buyer's place in line for the following litter. If the buyer fails to choose a pup from the second litter offered to them, then their name is moved to the bottom of the waiting list and the process restarts. (If a buyer declares a specific color and/or gender they intend to get at the time they pay their deposit, then their name doesn't move to the bottom of the waiting list until they have passed up two pups offered to them that are the color and/or gender they requested). A buyer on the waiting list can choose, at any time, to transfer to Option A by paying an extra \$200 deposit to claim an available 1<sup>st</sup> or 2<sup>nd</sup> pick from a specific litter for a total price of \$1500.00 USD (in this case their name will be removed from the Option B waiting list).

All deposits apply toward the total purchase price of the puppy.

The Buyer understands that the puppy is sold as is and shall have been de-wormed & received the first vaccination prior to leaving the Seller's custody.

The Buyer shall maintain the puppy in good condition, including adherence to a regular immunization schedule, good diet, and a clean and safe environment, where the dog will be happy. Seller reserves the right to repossess the puppy, with no refund, should the puppy ever be found in a state of reasonably irrefutable abuse or neglect.

If at any time in its life the puppy is to be sold or given away, the Buyer shall so notify the Seller and give the Seller first option to buy the puppy back at Buyer’s advertised sales price. Should Seller choose not to buy back the puppy, the Buyer agrees to provide the Seller with the contact info for the new owner.

The Seller agrees to sell the puppy with full breeding rights & no restrictions for breeding.

Payment for the puppy shall be in the form of Zelle, Venmo, Paypal “Friends and Family/Someone You Trust”, cash, check (when time is not of the essence) or direct deposit into Seller’s bank account, which will be provided if needed.

Puppies must be picked up at Seller’s location in Colorado. A buyer can come pick up the puppy themselves, or the Seller can arrange ground shipping for a puppy to be delivered to the Buyer. Cost for this service varies by location. Transportation of puppy from Seller to Buyer is the sole financial responsibility of the Buyer. Seller will do her best to help accommodate the Buyer in making the transportation plans so the travel goes smoothly and stress free for the puppy.

Puppies from DeMille Blue Bloods are loving, sweet, fun puppies that should make wonderful additions to your family. Buyer acknowledges that the puppy needs continued training and socialization to become a loyal, dependable, and obedient animal. Buyer accepts this responsibility solely and commits to providing the needed time to accomplish this with the new puppy.
